THE PROCEEDS OF CRIME ACT

THE PROCEEDS OF CRIME (DESIGNATED NON-FINANCIAL INSTITUTION) (TRUST AND CORPORATE SERVICES PROVIDERS) ORDER, 2022

In exercise of the power conferred on the Minister by paragraph 1(2) of the Fourth Schedule to the Proceeds of Crime Act (hereinafter referred to as "the Act"), the following Order is hereby made:—

- 1. This Order may be cited as the Proceeds of Crime (Designated Non-Financial Institution) (Trust and Corporate Services Providers) Order, 2022.
- 2. Any person to whom paragraph 3 applies is hereby designated as a non-financial institution for the purposes of the Act.
 - 3. This paragraph applies to any person who provides—
 - (a) a trust service; or
 - (b) a corporate service.
- 4. For the purposes of paragraph 3, "trust service" and "corporate service" have the meanings assigned to them under the Trust and Corporate Services Providers Act.
